Please come along, join us in using these facilities making a great social atmosphere.


Planned activities include Anzac Day tournament, Wimbledon Day, Garry Butler Shield against Kooroora and Presidents Day in December.

While it does not compare with the many important consequences of the pandemic, tennis over the past year has been greatly affected. For the first time in living memory, both the Garry Butler Shield and our Club Championships were unable to be played. However, thanks to the great effort put in by Tennis NSW and the Northern Suburbs Tennis Association there were still events throughout the year that our members were able to play in.

NSTA COMPETITION

There were 30 Lane Cove teams and 42 members that played in the various weekend NSTA competitions throughout 2021. Even with the disruptions from storms and lockdowns, 7 of our teams successfully made the finals of their divisions, with 4 of them claiming victories.

A special congratulations to all of our junior members who played in their first competition this year, you all put in a great effort and played amazingly. Thank you also to Daniel Martin, who has done a superb job supervising the Sunday Morning matches.

We had a particularly successful start to the year, with both the teams of Johnson Bai and Rohan Regnar, and Norman Donato and Corey Lewis coming first in their Term 1 divisions. Jake Spiden and Jack Phillips were also very competitive, falling just short in a close finals.

This success continued in Term 2, with Damon Wan and Ben Sung comfortable champions in Division 3, while Norman and Corey were able to defend their Division 2 victory. In the inaugural Sydney Junior Team Tennis Premier League, top guns Alex Morris and Thomas Garrett fell just short, trailing a strong Joeys 1 team. Hi Lane Cove Tennis Club community,

2021 was a productive year at the club as we work to improve your facilities.

Firstly, it is now over 12 months since we replaced the surfaces on our courts, and it has well and truly settled in. We hope to get 15 or so years life from this surface.

In addition to the usual maintenance and repairs, we carried out some significant clubhouse improvements in 2021. These included:

- New LED kitchen and bathroom lights
- Repaired the vandalised/ scratched glass windows and door on the patio side.
- Replaced the timber windows in the toilet and kitchen with white framed aluminium windows.
- Re-wired kitchen power circuit.
- New kitchen by APS Bathrooms & Kitchens. (The end result is great, and Phillip and his team were timely and accommodating)
- · New kitchen vinyl flooring and painting.

In 2022 we will be carrying out improvements to the bathrooms.
