The Breakfast Comp was a hit again, with 4 comps, 2 divisions, 22 players braving all weather conditions on Wednesday and Thursday mornings from 6:30am to 8:30am. Congratulations to the winners: Scott Button, Riki Uehara, Jamie Vandenberg, Michael Travares, Bryan Palmer and Ian Hilton. Thanks again to Guy Wynn for organising the comp.

Mornings and afternoons at the club were a hive of activity; special thanks to our fantastic coaches, Ella, Dom, and Gabriel, inspiring young kids to play the game. Also, thanks to Paul McNamara, who is training an elite group of teenagers at the club.

Our club remained a proud Northern Suburbs Tennis
Association member, actively participating in various
competitions, championships, and member forums. In 2023,
we supported NSTA's Centenary dinner and continued to field
teams in the Saturday afternoon and junior competitions.
Special shoutout to Kat Cho, Louis Turner, Glen Wilkins, and
Jenae Carroll, regular players in the Association's popular
night competition. And congratulations to Alex Morris for
clinching the NSTA Open Men's Singles title.

Congratulations to Corey Lewis, who was awarded NSTA 2023 Male Sportsperson of the Year for embodying fairness, ethics, respect, and sportsmanship on and off the court.

In December, we bid farewell to Redlands and its students, who had been hiring our courts for years. This farewell marks a new chapter for junior players, guided by Paul's Tennis Academy.

The Garry Butler Shield returned to our club in 2023, adding a junior division for the first time. Over 20 players competed to bring the Shield back home. Congratulations to Mischa Jeregui, who triumphed in the inter-club Lane Cove-Chatswood Championships, extending our club's championship reign for three consecutive years.

A huge shoutout to Sydney Veterans Tennis, who kept our courts busy with social play for their 50+ players. We appreciate their loyalty and flexibility, especially during school holiday camps.

We enjoy sharing our facilities with the clients of Ingrid Shaw's Gyrotonic, Pilates and Yoga Studio. The studio hosts state of the art equipment, led by leading instructors including Ingrid Shaw herself.

Organised social play continued Tuesday mornings and Saturday afternoons, thanks to Anna Barwell and the Committee. Special thanks to Matt Millward for lending a helping hand on Saturdays. In 2024, Anna is handing the baton to Reza Alizadeh.
















## Competition Secretary's Report

#### **CLUB CHAMPIONSHIPS**

The 2023 Club Championships was another very successful event, with over 50 players entering it and many of the eventual champions claiming their first titles at Lane Cove. Special thanks to those who went out of their way to make it possible to finish as many events as possible in time for the presentation day.

This year's Open Singles event started with one of the largest fields seen at Lane Cove for quite a while. After multiple great matches it came down to two of the top seeds battling it out in the finals. Congratulations to Joshua Muzik who completed his run through the event, defeating Matt Fisher 7–5 6–3 in an entertaining match. Congratulations also to tiebreak specialist Zaki Mohabbat, who spent a record amount of time on the court in multiple of the matches of the tournament.

Matt had more success in the Open Doubles, where he and his long-running partner Walid Mohabbat won in the finals 6-3 6-3 over John O'Brien and Zaki Mohabbat. Jenae Carroll and Sarn Ng were the champions of the Open Mixed Doubles, over Corey Lewis and Sue Woodward.

While timing issues meant that the Junior Singles events were unable to be played this year, Ben Muir and Risheet Mazumdar were the champions of the 18U Junior Doubles. In an extremely close match, they beat out Amelia Foate and Sabrina Mohabbat 7–5 6–7(4) (10–7).

After a couple of years break, congratulations to Paul Muller who claimed his third Veteran's Singles title, with a very close fought 7-6(6) 3-6 (10-7) win over Sarn Ng. Sarn did gain his revenge in the Veteran's Doubles though, partnering with John O'Brien to defeat Paul and Steve Smyth 7-5 6-0. In the Super Veteran's Doubles, Warren Welch and Mahmud Choudhury were too strong, beating Gordon Miller and Reza Alizadeh 8-3.

Dustin Roos claimed his first title in the Reserve Singles event, 6-2 7-6(5) over Kat Cho, while Tim Cook and Mahmud Choudhury claimed the Reserve Doubles title, beating the new partnership of Julia Song and Simon Li. Finally, Reza Alizadeh and Tim Cook were too strong on the day, winning the Handicap Doubles event over Norman Donato and Warren Welch.

#### NSTA COMPETITION

There were many great results by Lane Cove players in the NSTA Competitions throughout 2020. There were a record 59 teams that played for us throughout the year, with 19 of them making it to the finals of their divisions and 12 winning them!

Particular congratulations to Felix Liddy and Patrick Bates, who were the Division 7 SJTT champions in their first season of competition. Congratulations also to Nicholas Shanahan, Emma Leung and Jade Kirlew, and Caleb Heng, Ilya Kozlov and Tristan Lee who similarly made the finals in their first competitive seasons.

However, team of the year goes to Jenae Carroll, Keith Stewart and Tim Cook, who were the champions of their Saturday Doubles divisions in three out of the four seasons. Well done team!

Separately, two of our top juniors had excellent results in the 2023 NSTA Championships. Congratulations to Alex Morris, who was the champion of the Open Men's Singles event, and to Arin Gowda, who won the 8/U Boy's Singles without dropping a set throughout the whole event.

I hope you enjoyed 2023 at the club as much as I did! Lots of great tennis with our terrific tennis community made the year thoroughly enjoyable.

Firstly, here are just some of the many repairs and improvements carried out in 2023 by our amazing club member, Reza Alizadeh:

- fixing the patio "gap" problem with his ingenious work with aluminium chequer plates
- various net repairs
- the ice sculpture (Garry's 70th)
- painting
- bathroom door handle replacements (to bring up to safety standards)

The list goes on and on, and Reza also had time for the odd hit of tennis, including winning the Handicap doubles in the 2023 Club Championships! Thanks Reza, you are a true club champion!

Here are some of the other things done around the club in 2023:

 For safety (and aesthetics), we had the patio handrails replaced with the glass balustrades.

- In August we had the courts serviced by Sports Clean to keep them in top shape. This service includes rejuvenating the grass pile, topping up the sand and treating mould that tends to grow in winter.
- We replaced both our court sweepers, with new "Aussie Clean Sweeps".
- We purchased our new "Super Sopper" court drying machine.
- Replaced the tired, old green shade cloth along the clubhouse fence on court 3 with new black shade cloth.

Moving forward to 2024 our landlord, Lane Cove Council, are working on solutions to address clubhouse issues including concrete cancer affecting the ground floor slab, corroded subfloor and ground floor columns, and the subsided south facing clubhouse window frame.
